Projects will often be physically demanding and require volunteers to be able to lift ~50lbs, bend, twist, squat and/or stand for long periods of time.

In order to join us for a Project Volunteer Day, you MUST complete and submit a Project Volunteer Form by the Saturday before the project day! Limited spots are available for these projects and only volunteers that have completed this form and RSPV'd will be accepted the day-of the event! Volunteers will be accepted on a first-come, first-served basis.
